On April 19, a divided panel of the Federal Circuit reversed a lower court's judgment of invalidity because the defendant had not cross-appealed invalidity in a prior appeal involving the defendant's winning judgment of non-infringement. See *Lazare Kaplan Int'l, Inc. v. Photocopy Techs., Inc.*, Appeal No. 2012-1247 (Fed. Cir. 2012).
