

The case, argued before the Hon. Mr Justice Tugendhat, considered important issues of Canadian, English and European Union law relating to the compensation of



commercial agents. The English Court's decision followed a lengthy arbitration in Canada under the UNCITRAL Arbitration Rules. The decision, which has been widely reported internationally also focuses on the tensions applicable to selection of forum and choice of law where mandatory statutes may be affected.
