Modular housing eligible for NAHB green certification

Modular Green is a new service offered by the NAHB Research Center, which also administers the National Green Building Certification program for traditionally built homes. The verification service launched in February 2008 as part of NAHBGreen.

Green Coalition Submits Report to Obama

GreenBiz -Nov 26

A coalition of twenty-nine leading environmental, science and conservation organizations worked together to produce a 391-page "Transition to Green" report recently submitted to President-Elect Obama's transition team. Foremost among the groups' recommendations were calls to aggressively develop renewable energy resources and address climate change. "We need to dig ourselves out of the hole we're in with a green shovel," said National Wildlife Federation President Larry Schweiger, whose group

participated in producing the report.

Project FROG raises \$8 million

San Francisco-based Project FROG, a start-up that makes green modular buildings, announced that it has closed an \$8 million Series B financing led by RockPort Capital Partners. Project FROG has developed smart green building products and systems that are suited to a number of applications, including education, retail and commercial.

Hayward CA may adopt green building law

Like other municipalities across the country, Hayward, California is "going green". The city may adopt a green building ordinance that will require all new home construction and significant additions to both residential and commercial properties to achieve a GreenPoint rating based on five categories: energy efficiency, resource conservation, indoor air quality, water conservation and community. City Council members supportive of the ordinance believe it is needed to address the current economic downturn and the ongoing environmental emergency.

Napa CA considering green building law

North Bay Business Journal - Dec 1

The Napa City Council is considering the first phase of a green-building ordinance that will begin with mandatory measures for large commercial, institutional and public projects. New nonresidential buildings or additions with more than 30,000 square feet would have to qualify for the "certified" level of the USGBC's LEED rating system.

Webcor partners with Navitas in green building fund


