Pursuant to Rule 36 of the Federal Rules of Civil Procedure, Plaintiff STEVEN E. KROLL requests that defendant IVGID¹ admit within thirty days after service hereof, for the purposes of this action only, the truth of the facts, application of law to fact, or opinions about either as set forth hereafter.

Defendant IVGID's Responses to these Requests for Admissions shall specifically admit or deny each separately stated matter, or set forth in detail the reasons why it cannot truthfully

admit or deny the matter. A denial shall fairly meet the substance of the requested Admission, and when good faith requires that defendant IVGID qualify its answer or deny only a part of the matter of which an admission is requested, it shall specify so much of it as is true and qualify or deny the remainder. Defendant IVGID may not give lack of information or knowledge as a reason for failure to admit or deny unless it states that it has made reasonable inquiry and that the information known or readily obtainable by it is insufficient to enable it to admit or deny. - 5. - 7. On July 3 and 4, 2008 IVGID's Beach Properties were closed to the general public.⁴
- 8. On July 3 and 4, 2008 IVGID's Beach Properties were open for entry only to certain Incline Village property owners and their guests.
- **9**. On July 3 and 4, 2008 District property owners in Crystal Bay who were not also owners of property in Incline Village or guests of owners of property in Incline Village were discriminated against in participating in the RWTB events set forth in Request for Admission Number 5.


Dear Board Members,

Chairwoman Bea Epstein has requested I respond to Mr. Mark Alexander, through you, regarding two e-mails dated September 11, 2008, 2:53 PM and November 4, 2008, 9:24:10 PM. I did not receive these two e-mails and have checked with the District's Information Technology team to confirm that these e-mails were not received by me; it has been confirmed that our District e-mail server does not show receipt of the September 11, 2008 e-mail.

Answers to Mr. Mark Alexander's questions and his comments/statements:

- 1. Is Red, White & Tahoe Blue, under its 501 c 3 classification, a "Private Foundation" or a "Public Charity"? <u>Answer: Public Charity</u>
- 2. In its filing with the IRS did Red, While & Tahoe Blue declare that it conducts discriminatory events that excluded selected members of the community (as well as the general public) from participation? If yes, please forward a copy of that declaration. <u>Answer: RWTB does not conduct events which discriminate; therefore, the RWTB declaration was that it does not discriminate. The Board of Trustees, prior to my employment with the District and involvement with RWTB, allowed access to the beaches for viewing of the fireworks after 8:00 PM every July 4. The fireworks can be viewed from a multitude of venues around Incline Village and Crystal Bay. Board members of RWTB have for the past two years purchased punch cards which they have provided to anyone who requested access to RWTB events.</u>

Answer: The Board of Trustees does not require me nor does my job description to maintain a separate time record. My job description states "Represents IVGID to the media, community groups and various government agencies. Confers with and responds to citizens and customers regarding requests for services, suggestions and complaints". The Board of Trustees that hired me asked me to repair, through my active participation in Incline Village and Crystal Bay events, the deplorable relationship the community had with the District and I responded to that direction and to continue to respond to that direction.

- 4. Can you please confirm that your workday hours involved in the past and forthcoming period in support of Red, White & Tahoe Blue activities and events have not nor will be paid through other means beyond your IVGID salary? <u>Answer: RWTB members do not receive any type of compensation for their involvement; all members are unpaid volunteers.</u>
- 5. Can you please confirm that expenses that you have or will incur related to or in support of Red, White & Tahoe Blue have not nor will in the future be reimbursed by IVGID? <u>Answer: To the best of my knowledge, I have not nor will I in the future incur expenses as a result of my volunteering to serve on the RWTB Board.</u>
- 6. Has the IVGID BOT endorsed your role in Red, White & Tahoe Blue? If yes, please advise which set of BOT Meeting Minutes stipulate that endorsement. <u>Answer: The Board of Trustees has always supported my involvement in the community and has never asked me to stop officially from my involvement; however, I was asked by one Board member in the past to resign as the Chairman of Independent Incline after serving as Chairman for two years. As previously mentioned, my involvement in the community is included in my job description; a copy of which is hereto attached.</u>

As the General Manager of the Incline Village General Improvement District, I have done nothing wrong; however, if the Board of Trustees believes my leadership roles in the community leaves one ounce of question as to my integrity or perceptions for the District, then the Board of Trustees has the option of requesting that the General Manager resign from all community Boards and activities immediately; the appropriate job description changes will be made as well at that time. And/or, if you want me to start keeping a separate time record for the activities I undertake each day, please direct me to do so.

Responding to Mr. Alexander's concern related to RWTB and the IRS, RWTB does not discriminate against anyone, and RWTB welcomes an investigation by the IRS.
