A much awaited trade promotion authority ("TPA") bill was introduced in the House and Senate on January 9 by Ways and Means Committee Chairman Dave Camp (R-MI) and Finance Committee Chairman Max Baucus (D-MT). The legislation (H.R. 3830/S. 1900) would provide for fast-track congressional consideration of trade agreements negotiated by the Administration, including the ongoing Trans-Pacific Partnership (TPP) negotiations with countries such as Australia, Thailand, Malaysia, Singapore, Philippines, and Japan and the nascent Transatlantic Trade and Investment Partnership (TTIP) negotiations between the United States and EU countries. Dodd-Frank: The Volcker Vortex

In its simplest form, the Dodd-Frank Act's Volcker Rule prohibits U.S. bank holding companies and their affiliates from engaging in "proprietary trading" and from sponsoring hedge funds and private equity funds. While the original idea was straightforward – to prevent speculative, excessively risky activity by insured depository institutions – drawing a clear line between proprietary trading and permissible market-making activity has proven much more difficult than many had anticipated.
