# Valentines Day Recipe Mouthwatering Fudge

Valentine's Day is certainly the right time to make special desserts for those we love and care about. This month's recipe is a perfect way to celebrate a special relationship or just treat yourself and your family in the middle of a cold winter. If your loved one is tongue-tied when it comes to expressing his/her feelings, let this mouthwatering fudge recipe do the talking.



### Ingredients

Dark Chocolate Layer: 1 1/4 cups semisweet chocolate chips 1/2 cup sweetened condensed milk Dash of salt White chocolate Layer: 1 1/4 cups white chocolate chips 1/2 cup sweetened condensed milk Dash of salt Other ingredients and Materials: Aluminum foil 64 conversation hearts 64 red mini muffin cups Clear or red cellophane wrap, cut 64-5x6" rectangles

### Instructions

Line an 8-inch square pan with aluminum foil. Set aside. In a bowl, combine the dark chocolate layer ingredients. Microwave the mixture on high at 30-second intervals until the chocolate is melted. In another bowl, combine the white chocolate layer ingredients. Repeat the melting process. Spread the white chocolate evenly over the dark chocolate layer. While the fudge is still warm, use a knife to gently score it into 1-inch squares, then put a candy heart on top of each square. Chill the fudge uncovered in the refrigerator for at least 2 hours or until firm. Lift the foil to remove the fudge from the pan and place the whole hunk of fudge on a cutting board. Use a large knife (a parent's job) to cut apart the squares, then peel off the foil from the bottom. Place each fudge square into a mini muffin cup. Center the cup on a cellophane square and wrap it, using 1-inch pieces of pipe
