The Family Policy Compliance Office (FPCO) advises that a photo or video of a student is an education record, subject to specific exclusions, when the photo or video is: (1) directly related to a student; and (2) maintained by an educational agency or institution or by a party acting for the agency or institution. The issue is in regard to defining when a record, is in fact, directly related to a student, and when it is not. This threshold is important because a record not related to a student is not subject to FERPA restrictions. <u>Read more</u>

### <u>New Report Says FAA Should Revise its Drone Risk Assessment</u> <u>Processes</u>

A new report issued by the National Academies of Sciences, Engineering and Medicine says that the Federal Aviation Administration (FAA) should revise its approach to safety risk assessments for the technology associated with the implementation of drones into the national airspace. Specifically, the report says that the FAA's overly conservative approach to safety risk assessments can be a significant barrier to the introduction and development of emerging and rapidly changing technology in the drone arena. <u>Read</u> <u>more</u>

### FCC Proposes Fine Against HobbyKing for Non-Compliant Drone Devices

Recently, the Federal Communications Commission (FCC) proposed a \$2.8 million fine against HobbyKing for allegedly marketing to amateur drone operators non-compliant models of devices used to relay video feed from the drones. Specifically, HobbyKing, a Hong Kong-based drone distributor, allegedly markets drones that transmit video in unauthorized radio frequency bands, and operate at excessive transmission power levels. The FCC says this type of transmission could interfere with key government and public safety services such as aviation systems and weather radar systems. <u>Read</u> <u>more</u>

In the age of web-connected vehicles, the consumer's relationship with the vehicle's manufacturer takes on a whole new meaning. Not only does the relationship exist for the purpose of vehicle maintenance or future repairs, but the consumer also serves as a rolling information bank for the manufacturer. Indeed, nearly every new vehicle is by default programmed to share consumer data with manufacturers.
