Bennett felt the acquisition would not lead to any immediate change in the ongoing disputes between the parties. "'Obviously, I don't know what their internal strategies are going to be, but in the end I would say it's not going to change a lot,' Bennett said. She added that each company will continue to expand into new territories and that each new territory will bring a new conflict. 'We won't be here in 100 years, but our grandchildren will be having the same conversation because those brands will still be here,' Bennett said."


