U.S. EPA removes "opt-out"

provision from Lead Rules

In a recent SZD Client Alert, we provided

May 17, 2010

information regarding the Lead
Renovation, Remodeling and Painting
(RRP) Rules promulgated by U.S. EPA,
which became effective April 22, 2010.

PLEASE NOTE: U.S. EPA has eliminated the
"opt-out" provision from the RRP Rules
that allowed the owner of a single family
home to "waive" the use of lead safe work
practices by a renovation firm if no child
under six years of age or pregnant women
reside in the home.

With the elimination of the "opt-out" provision, the RRP Rules require that anyone who receives compensation for renovation work at single family homes, multi-family housing and child-occupied facilities (such as day care facilities and schools) built before 1978 must use a

certified firm or individual to perform this work. Essentially, this now means that anyone other than the owner/occupant of a single family home is subject to the RRP Rules
