#### 10. Student vs. SMMUSD, OAH Case No. 2013051152

Administrative Law Judge (ALJ) Eileen M. Cohn, determined on December 23, 2013 that the SMMUSD must reimburse parents for all of their tuition costs for a Non-Public School (NPS) along with reimbursement for all tutoring expenses.

These amounts exceed \$56,970.99 in tuition reimbursement thus far, and does not include attorneys fees. Attorney's fees will be significant.

The SMMUSD's adversarial posturing is costing the SMMUSD hundreds of thousands of dollars and causing unnecessary harm to these families.
