I was born on May 4, 1969 at Yuma, Arizona, United States of America.

I married EDUARDO GONZALES-ESCALANTE, on September 1, 1999 at San Francisco, California. Edguardo and I have known each other since January 1999. We have lived together from June 1999 to the present. We have had no periods of separation from each other since we began to live together in June 1999. We have no plans to terminate our marriage. Eduardo and I have an infant son, Paco, who is ten months old.

Eduardo and I have a very close and loving relationship. He provides me with companionship and friendship. He also provides me with important emotional support in my day-to-day life. I rely on him for someone to talk to, share my concerns and frustrations and my plans for the future. Eduardo is my life companion, lover, close friend, and father of my only child. If Eduardo is not allowed to live with me in the United States I would feel a great loss and do not know how I would be able to get along without him.

Eduardo is also an important part of our son's life. It is very important to me that our son is raised in a family atmosphere with both parents present. I would be very sad and unhappy if I had to become a single mother. I also believe that it is especially important for my son to have his father as a male role model in his life.

Eduardo is employed as a full case picker at Gourmet Life Foods, West Division in Hayward, California. He earns approximately \$26,000.00 per year, not including all the overtime he puts in as he is such a hard worker. I am employed as an automation support analyst with Zuckerman, LLP, and earn about \$51,442.00 per year, but Eduardo's income is very important to the financial well-being of our household, especially since we live here in the Bay

Area, where life is so expensive. Eduardo and I are constantly trying to improve our current living condition and save for our future, and the future of our son. Eduardo provides me and our son with life insurance through his job. Currently Eduardo and I are beginning the process of buying a house together, which has always been a dream of mine. Thanks to Eduardo's additional income, I hope to be able to realize this dream for my family.
