### **Second Circuit Clarifies Scope of Post-Award Judicial Review of Arbitrability**

The Second Circuit recently clarified the scope of the so-called "competence-competence" doctrine and affirmed that where a party agrees to arbitrate under rules that authorize an arbitration tribunal to rule upon its own jurisdiction, a party who subsequently opposes confirmation of an award will be foreclosed from obtaining independent judicial review of the tribunal's arbitrability determinations.

## Ninth Circuit Rejects Plaintiffs' Claims for Damages for Alleged Climate Change-Related Injury

The Ninth Circuit's holding in *Kivalina* forecloses the use of "federal common law" to create a cause of action where none previously existed. The decision affirmed that the Clean Air Act displaces an Alaska Native village's claim for money damages against select oil, coal, and utility companies for historic emissions of significant quantities of greenhouse gases under a theory of federal common law nuisance.
