

## **Buena Park Accident Injures Six Adults, One Child**

A two-car accident in Buena Park resulted in injuries to six adults and one child as well as the arrest of a woman brandishing a knife, according to a [news report](#).

Buena Park police said that officers were called to investigate a crash involving a Lexus ES 300 and a Pontiac Grand Am at Beach Boulevard and Los Coyotes Drive. Following the crash, the driver of the Pontiac Grand Am – 21-year-old Debra Ponce of Whittier – reportedly threatened the Lexus driver with a knife and physically assaulted her. Ponce then left the scene, only to return a short time later with her four-year-old son. She began to fight with police officers and was arrested on suspicion of assault with a deadly weapon.

Three men, three women and the four-year-old boy were taken to local hospitals; one passenger in the Grand Am suffered traumatic injuries and the others sustained non-life threatening injuries according to police.
