- 4. All Internet subscribers, domain owners,
 Internet Service Providers ("ISPs"), Online Service
 Providers ("OSPs"), Interactive Computer Services
 ("ICS"), and the like are intended, third-party
 beneficiaries of this Injunction. In the event that
 violation of this Injunction by Defendant results in harm
 to any such third-parties, the aggrieved Internet
 subscriber, domain owner, ISP, OSP, ICS, and the like,
 shall have, and may properly assert, against Defendant
 any and all rights under this Injunction in relation to
 such harm, as can Plaintiff, in the event that Plaintiff
 had been the victim of such harm.
- 5. In the event that Defendants' violation of this Injunction injures or aggrieves Plaintiff, and/or Plaintiff's officers, employees, or agents, Defendants shall be liable, jointly and severally, to each party in the full amount of the damages to each party. Any party aggrieved by Defendants' violation of this Injunction shall have the right to seek any legally cognizable damages it suffers.
- 6. Awarding Plaintiff damages in the amount of \$1,000,000 pursuant to California law.
- 7. Awarding Plaintiff monetary relief for its costs in this action in the amount of \$648.45 as provided in Fed. R. Civ. P. 54, Local Rule 54-1, et seq, California Code of Civil Procedure (CCP) § 998, CCP § 1032, and related provisions of law.
