Our Very Own Enquiry System



We are delighted to announce that the Society has developed an online enquiry system to help solicitors refer work to our members, or to obtain court cover at short notice.

Known as Instruct+ ®, the system forms part of our new website, which is due to be formally launched at the AGM. It will work like this:

Imagine that you have an appearance scheduled in the High Court in Glasgow, but you are also needed in Hamilton Sheriff Court later that same morning. You need help quickly; to give you time to properly instruct alternative representation.

Instruct+ allows you to complete a very basic website form – with your details, the area of practice your case concerns, the date, time and location – and email it to SSA members who practice in that field. No confidential information is required.

Those members who are free - and interested in offering their services - will then be able to contact the enquiring solicitor directly.

Members who are not free or not interested, do not need to do anything at all.

Members who have downloaded our Instruct+ app will also receive the message via the app, ensuring that they can respond quickly to enquiries, even when on the go.

All the communication involved, with the exception of the initial enquiry email and push message, will be made outwith Instruct+, and it will be up to the parties to sort out all the necessary arrangements. The Society, and Instruct+, will play no part in this.

The aim of the system is not only to make it easier for instructing solicitors to contact members of the Society, but to raise the profile of solicitor advocates among solicitors generally.

The plan is to automatically sign everyone up to Instruct+ when the new website launches, although you will be able to opt out if you prefer. You will all be able to login to Instruct+ using your existing membership login details and should be able to send and receive messages as soon as the system goes live.

We will let you know when this happens.

Finally, a few points to note:

- You can download the app from the App store right now, but it will not work until the system goes live.
- Those of our members who work for COPFS will not be able to receive enquiries;
- People who abuse the system will be taken off it; and
- The system will not work for you if your membership subscription is overdue! You have been warned!

Shaping Scotland's Court Services

The Society of Solicitor Advocates is planning a response to the recently launched Scottish Court Service (SCS) consultation on proposals for court services in the High Court, sheriff courts and justice of the peace courts.

Civil and criminal justice will be reformed in the coming years following the recommendations arising from the reviews by Lord Gill, Lord Carloway, Sheriff Principal Bowen and the forthcoming Victims and Witnesses Bill. Further changes are also anticipated following the report by the Commission on Women Offenders, chaired by Dame Elish Angiolini.

The SCS believes that these reviews will have implications for how and where court services will be delivered in the future, and is taking steps to prepare for the changes.

Full details of the proposals can be found in the consultation document.

If you have any comments that you would like the Society to put forward on your behalf, please let us know by the end of November. The consultation will close on 21st December.

Appeals Video Link Trial

The Scottish Courts Service has been looking at the use of video links for appeals, with the appellant observing proceedings from prison.

In the first instance this will be tested in solemn conviction appeals – with a test date scheduled for 22nd November.

The Appeal Court will be sitting in Court 5, Parliament House, and anyone interested in watching should attend the court in good time, bearing in mind that Court 5 has limited seating capacity.

Westlaw

The Society contacted Westlaw earlier this year to try to establish what would be involved in a group subscription to the service.

Westlaw have advised that they would be able to offer a 15% discount to members of the Society of Solicitor Advocates, but that each member would have to negotiate their subscription themselves. The cost of the subscription would depend on the particular circumstances of each member/firm.

As a very rough guide, Suzanne advises that a small law firm with two fee earners would expect to pay around £6,500 for Westlaw UK or £3,200 for the Scots Law service, without the discount.
