### **SLG Assists in Jury Trial Victory**

D. Todd Smith participated in a jury trial resulting in a complete victory for a client sued after a failed real-estate transaction. Smith handled the legal issues in the case, including the jury charge. The trial court directed a defense verdict on two theories, and the jury found for the firm's client on all remaining claims.

### Firm Wins Discovery Mandamus

SLG prevailed in a mandamus proceeding in which a corporate defendant attempted to avoid discovery relating to Texas lawsuits arising from similar accidents over the past five years. Plaintiff sought the information to identify other accidents in which it was alleged that a company driver was negligent, that the defendant did not employ proper safety measures, or that the defendant was negligent regarding vehicle operation policies, driver training, or setting safety policies. *In re Waste Mgmt. of Texas, Inc.*, No. 13-11-00197-CV, 2011 WL 3855745 (Tex. App.—Corpus Christi Aug. 31, 2011, [mand. filed]). Brandy Wingate was lead counsel for the real party in interest.

#### **Amicus Curiae's Position Prevails**

SLG represented an amicus curiae in an appeal in which the City of Austin denied approval of a site plan to build a hotel. The City rejected the plan as a change in project from a preliminary plan filed in 1985. The appellate court held that the proposed hotel was part of the project initiated in 1985 and a permitted use under the Barton Creek Watershed ordinances and regulations then in effect. *Harper Park Two, LP v. City of Austin*, No. 03-10-00506-CV, 2011 WL 3658923 (Tex. App.—Austin Aug. 18, 2011, no pet. h.). Todd Smith was counsel for the amicus, which supported the developer's position in the case.
