"How can I be sure?" - Checking for Illegal Workers

Employers face increasing pressure to ensure their workforce is not working illegally. In the last financial year UK Border Agency (UKBA) imposed £7 million in civil fines on businesses employing illegal workers. A visit from the UKBA can result in a £10 000 fine for each illegal worker found, so remaining complacent is not an option.

How can employers prepare?

- For each employee do you have a copy of a document which proves their right to work in the UK?
- Did you take reasonable steps to ensure that the employee is the rightful owner of the document?
- Did you take copies before the employee started work?
- Did you note who took the copies and when?
- Did you note if an employee's permission to work is limited?
- Do you have up to date contact details for employees requiring work permission?
- Did you diarise to follow up when an employee's work permission ends?
- Do you have systems in place which can identify if and when an employee requiring work permission is no longer in your employ?

The above checklist only addresses prevention of illegal working regulations. Tier 2 or 4 sponsors have additional reporting and record keeping responsibilities, increasing the potential to get it wrong. Typical problems sponsors encounter could be any of the following: not ensuring the employee's salary level meets UKBA requirements, not informing UKBA when an employee leaves, or failing to notify UKBA in time when taking on new staff as a result of a TUPE transfer.
