- A. AL2013-057, Renal Care Group of the Southeast, Inc., Andalusia, AL: Proposes to expand by adding eight hemodialysis stations to the newly relocated facility currently consisting of two home training stations, one isolation station (pursuant to CON 2551-ESRD), and 10 hemodialysis stations.
