hen I started as a solo lawyer, my practice involved criminal defense, debt collection, family law, appeals, corporate law, consumer protection issues (including the Fair Debt Collection Practices Act), bankruptcy and civil litigation.

rom A pril 1, 1993 to December 31, 1997, I was a partner in Hasler & Maynard, P.C.. I returned to a solo practice in 1998 and then on July 1, 2000, I was hired by Dorn & Associates, P.C, and moved to Indianapolis.

orn provided pre-paid legal service to members of various union Carpenter and Millwright Locals. I left Dorn in September of 2002 dissatisfied with the limited practice areas of a pre-paid legal services program.

t this point in my career I took the time to reevaluate whether I wanted to return to private practice and, if so, where. I returned to Anderson in May of 2003 and restarted my private practice. Since that time, I have had a private practice and limited my practice to family law and business law matters generally with also a smaller work in probate and consumer law matters.

   such as trade secrets.
- 3. Creating contracts and creating non-compete agreements.
- 4. Collections representing creditors in bankruptcy court as well as ordinary consumer and commercial collections.
- 5. Enforcing/defending contracts, trade secrets, and non-compete agreements.
- 6. Start ups: establishing new businesses
