FIRST AMENDED PETITION FOR WRIT OF MANDAMUS

TO THE HONORABLE JUSTICES OF THE COURT OF APPEALS:

Relators, James A. Baker and Julia Maldonado petition the Court for a Writ of Mandamus directing Jared R. Woodfill, V, the Chairman of the Harris County Republican Party to omit Ricardo L. Ramos ("Rick Ramos") from the Republican Party General Primary Ballot for District Judge for the 308th District Family Court because Rick Ramos's application and petition to place himself on such ballot does not meet the statutory requirements of Texas Election Code.

PARTIES

- 1. Relators are James A. Baker and Julia Maldonado.
- 2. Jared R. Woodfill, V, Chairman for Harris County Republican Party is Respondent.
 - 3. Ricardo L. Ramos ("Rick Ramos") is a Real Party in Interest.
 - 4. Beverly Kaufman, Harris County Clerk, is a Real Party in Interest.
 - 5. Hope Andrade, Texas Secretary of State, is a Real Party in Interest.

REQUEST FOR ORAL ARGUMENT

Relators request that the Court set this case for oral argument.

STATEMENT OF JURISDICTION

"Court of Appeals concern[s] itself with whether law of the land was followed, not whether parliamentary rules were followed." *See In re Dupont*, 142 S.W.3d 528 (Tex.App.-Fort Worth, 2004). This Court has jurisdiction to issue a writ of mandamus. For instance, this Court may compel a political party officer to perform a duty imposed by law in connection with an election. *See* TEX. ELEC. CODE §§ 161.009 and 273.061 and *In re Cahill*, 267 S.W.3d 104, 105 (Tex.App.-Corpus Christi, 2008).

Relator James A. Baker has a special interest as he is a Registered Republican in Harris County, Texas and a member of the Republican National Committee Advisory Board. Relator Julia Maldonado is a candidate for the same office as Rick Ramos.

Therefore, Relators have standing in this matter. See TEX. ELEC. CODE §§ 273.081, In

re Jones, 978 S.W.2d 648, 651 (Tex.App.-Amarillo, 1998), and *Brimer v. Maxwell*, 265 S.W.3d 926, 928 (Tex.App.-Dallas, 2008).

STATEMENT OF THE ISSUE

On January 4, 2010, an application was filed to place Ricardo L. Ramos ("Rick Ramos") on the Republican Party General Primary Ballot as a candidate for District Judge of Harris County 308th District Family Court. Is this application invalid because it does not meet the requirements of Texas Election Code, Section 172.021(e)? If so, must Jared R. Woodfill, V, Chairman of Harris County Republican Party, omit Rick Ramos's name from the Republican Party General Primary Ballot?

STATEMENT OF THE FACTS

On January 4, 2010, an application was filed to place Ricardo L. Ramos (herein "Rick Ramos") on the Republican Party General Primary Ballot as a candidate for District Judge of Harris County 308th District Family Court (herein "Application").

Because Rick Ramos is running for District Judge in Harris County, as required under Texas Election Code, Section 172.021(e), his Application is accompanied with a Petition for Judicial Officer (for use in a primary election) (herein "Petition"). This Petition consists of thirty-eight pages with signatures of registered voters (*See* Appendices, Appendix 3, which is to be incorporated by reference). Of these thirty-eight pages, only five pages designate which political party Rick Ramos is affiliated with. (*See* Appendices, Appendix 3 at Pages 35-39). These five pages contain a total of thirty-five signatures of registered voters.

On January 8, 2010, James A. Baker requested that Jared R. Woodfill, V, the Chairman of Harris County Republican Party (herein "County Chair"), omit Rick Ramos's Application because it obviously did not comply with Texas Election Code (*See* Appendices, Appendix 4, which is to be incorporated by reference). County Chair has continues to refuse to perform his duty as imposed by Texas Election Code.

SUMMARY OF ARGUMENT

Ricardo L. Ramos's (herein "Rick Ramos") application to place himself on the Republican Party General Primary Ballot for District Judge of Harris County 308th

District Court (herein "Application") does not comply with Texas Election Code, Section 172.021(e) that requires the signatures of a minimum of two-hundred and fifty registered voters to accompanying such application. Note that Rick Ramos's Application is accompanied with a Petition for Judicial Officer (for use in a primary election) (herein "Petition").

Specifically, Texas Election Code, Section 141.063(4) requires, for a signature to be valid, that statements that are to be placed on each petition at the time of the registered voter signing such petition. One of these statements, pursuant to Texas Election Code, Section 172.027, is the political party's name.

Here, only five pages of Rick Ramos's Petition contained which political party's name he is affiliated with. These five pages contain a total of thirty-five signatures of registered voters. Not having met the minimum requirement of Texas Election Code, Section 172.021(e), Rick Ramos Application does not comply with Texas Election Code.

Pursuant to Texas Election Code, Section 172.029(d), Jared R. Woodfill, V, being the Chairman of Harris County Republican Party (herein "County Chair"), is under a duty to omit Rick Ramos's name from the Republican Party General Primary Ballot for District Judge of Harris County 308th District Court. Having refused, persuant to Texas Election Code, Sections 161.009 and 273.061 this Court must compel County Chair to maintain this duty.

ARGUMENT

A. This Case Satisfies the Standard for Mandamus Relief

"Court of Appeals concern[s] itself with whether law of the land was followed, not whether parliamentary rules were followed." *See In re Dupont*, 142 S.W.3d 528 (Tex.App.-Fort Worth, 2004). Furthermore, this Court has original jurisdiction to issue a writ of mandamus. In the instant case, this Court may compel a political party officer to perform a duty imposed by law in connection with an election. *See* TEX. ELEC. CODE §§ 161.009 and 273.061 and *In re Cahill*, 267 S.W.3d 104, 105 (Tex.App.-Corpus Christi, 2008).

Here, the underlying issues revolves around County Chair refusing to maintain his duty by omitting Rick Ramos from Republican Party General Primary as his Application is obviously inadequate pursuant to Texas Election Code.

B. Overview of Applicable Texas Election Code

In Harris County, in an application for an individual to be placed on any party's general primary ballot as a candidate for district judge he or she must also attach a Petition for Judicial Officer (for use in a primary election) containing valid signatures of

a minimum of two-hundred and fifty registered voters. *See* <u>TEX. ELEC. CODE §§</u> 172.021(e).

For a signature to be valid, statements are to be placed on each petition at the time of the registered voter signing such petition. *See* <u>TEX. ELEC. CODE §§ 141.063(4)</u>.

One of these statements is the political party's name. *See* <u>TEX. ELEC. CODE §§</u> 172.027.

County Chair is under a duty to follow Texas Election Code. County Chair is under a duty to review a candidates application. *See* TEX. ELEC. CODE §§ 141.032. If a candidate's application is invalid, County Chair must omit his or her name from the ballot. *See* TEX. ELEC. CODE §§ 172.029(d) and *In re Gamble*, 71 S.W.3d 313, 321 (Tex., 2002).

This Court must compel a County Chair to maintain this duty. <u>TEX. ELEC.</u>
CODE §§ 161.009 and 273.061

C. Because Rick Ramos's Application Doesn't Comply with Texas ElectionCode, It Must be Omitted

In *In re Gamble*, Judge Gamble filed his application have his name placed on the Republican primary ballot identifying the office sought as "Judge, 190th Civil Dist. Court." *In re Gamble*, 71 S.W.3d 313, 315 (Tex.,2002). Judge Gamble's petition accompanying his application identified "District Judge, 270th Judicial District" as the elected office he sought. *Id.* Judge Gamble's application was found not to comply with Texas Election Code.

Here in Rick Ramos's Application and Petition, it does not comply with Texas Election Code, Section 172.021(e) that requires the signatures of a minimum of two-

hundred and fifty registered voters to accompanying such application. Specifically, Texas Election Code, Section 141.063(4) requires for a signature to be valid that statements are to be placed on each petition at the time of the registered voter signing such petition. One of these statements, pursuant to Texas Election Code, Section 172.027, is the political party's name.

Here, only five pages of Rick Ramos's petition contained the political party's name that he is affiliated with. These five pages contain a total of thirty-five signatures of registered voters. Not having met the minimum requirement of Texas Election Code, Section 172.021(e), Rick Ramos Application does not comply with Texas Election Code.

Pursuant to Texas Election Code, Section 172.029(d), Jared R. Woodfill, V, being the Chairman of Harris County Republican Party (herein "County Chair"), is under a duty to omit Rick Ramos's name from the Republican Party General Primary Ballot for District Judge of Harris County 308th District Court. Having refused, persuant to Texas Election Code, Sections 161.009 and 273.061 this Court must compel County Chair to maintain this duty.

PRAYER

Relators respectfully requests that this Court grant this writ of mandamus compelling County Chair to omit Rick Ramos's name from the ballot of the Republican Party Primary Election for District Judge of Harris County 308th District Court.

Since this litigation became necessary because County Chair has refused to maintain his duty as required by Texas Election Code, Relators requests for attorney fees

and court costs, in the excess of \$3,000.00 (See Appendices, Appendix 5 which is to be incorporated by reference).

Relators requests for general relief.

Relators request an oral argument.

Because the Primary Election is March 2, 2010 and the defects in Rick Ramos's Application and Petition are obvious, Relators pray that this Court will immediately grant Relators' First Amended Motion for Temporary Relief filed contemporaneously herein.

Dear Mr. Woodfill:

I am writing to bring to your attention irregularities in the Petition in Lieu of Filing Fee referenced above.

The petition filed by Mr. Ramos is fatally defective because it fails to comply with the express requirements of the Texas Election Code.

Under Section 172.027 of the Code, the party name must appear in the petition. On 33 of the pages of Mr. Ramos' petition he does not name either the Republican or Democratic Party.

The petition of Mr. Ramos contains signatures from Colorado and Montgomery County voters, and without those signatures his petition does not contain the number required by the Code.

More than fifteen percent of the persons who purportedly signed Mr. Ramos' petition are not registered voters.

Many of the pages in the petition contain blanks in which required information has not been completed. At least one page of the petition does not disclose the month when the primary is to be held. Many of the pages of the petition do not name the office for which he is running. At least one of the pages of the petition is missing the date on which the persons signed.

Mr. Ramos' legal name is Ricardo Ramos. His petition is in the name of "Rick" Ramos.

If the Harris County Republican policy certifies Mr. Ramos' petition I intend to challenge Mr. Ramos' candidacy in Court as permitted by Section 161.009 of the Election Code.

DICK, known to me to be the person whose name is subscribed to the following instrument, and acknowledged to me that he executed the same for the purposes and consideration therein expressed.

- 1. My name is Eric B. Dick. I am over the age of twenty-one (21) and am capable of making this Affidavit. The facts stated in this Affidavit are within my personal knowledge and are true and correct.
- 2. I am the founder of my law firm, the Dick Law Firm in Houston, Texas. I have an extensive education and a wide range of legal experience.

For example, I was the only intern (one of two people) working with the Master Settlement Agreement for the state of Michigan. The Master Settlement Agreement is an agreement with the seven largest tobacco companies to pay forty-six states an estimated two-hundred-and-six billion dollars. This agreement is the *largest* civil settlement in United States history.

I received a scholarship for academic performance and graduated *cum laude* from Thomas M. Cooley Law School – the largest law school in the United States, ranked by *Judging Law Schools* as twelfth for "Overall Rankings 2008," and ranked by *Princeton Review* as sixth for having "Most Competitive Students." In law school I was active in both Moot Court and Mock Trial.

After law school, I interned with the Welfare Fraud division of Harris County District Attorney's Office. Currently, I am completing an LLM in Taxation at the University of Alabama – ranked eleventh among public law schools and thirty-second among all law school in the nation, according to *U.S. News and World Report's 2009* edition of its annual "Best Graduate Schools" publication.

I have substantial experience writing a Petition for Writ of Mandamus.

As an attorney who has practiced in Harris County and its surrounding counties. I am familiar with the usual and customary fees which are charged in the Houston, Harris County area for services of the type that have been rendered in this case.

- 3. I was hired by James A. Baker and Julia Maldonado ("Relators") to represent them in this dispute. It is customary in the Houston, Harris County greater area for clients to be charged an hourly rate for legal services in cases such as this. I am familiar with the legal issues involved in this matter.

- 5. I am familiar with the following factors under the Texas Disciplinary Rules of Professional Conduct 1.04, which should be considered when determining the reasonableness of a fee:
 - a. The time and labor required, the novelty and difficulty of the questions involved, and the skill requisite to perform the legal service properly;
 - b. The likelihood, if apparent to the client, that the acceptance of the particular employment will preclude other employment by the lawyer;
 - c. The fee customarily charged in the locality for similar legal services;
 - d. The amount involved and the results obtained;
 - e. The time limitations imposed by the client or the circumstances;
 - f. The nature and length of the professional relationship with the client;
 - g. The experience, reputation, and ability of the lawyer or lawyers performing the services; and
 - h. Whether the fee is fixed or contingent on results obtained or uncertainties of collection before legal services have been rendered.
- 6. My hourly rate is currently \$175.00 per hour. Based on my qualifications, education, and experience as a lawyer in the greater Harris County, Houston, Texas area, these rates are customary and more than reasonable.
- 7. I periodically need the assistance of a law clerk or a paralegal in representing my client in this matter.
- 8. In this matter, I estimate that from Respondent refusing his duty to omit Rick Ramos from the ballot my client will occur in excess of \$3,000 in attorney fees, related expenses, and court costs (see attached exhibit which is to be incorporated by reference).

Appendix 6:

- § 141.032. REVIEW OF APPLICATION; NOTICE TO CANDIDATE.
- (a) On the filing of an application for a place on the ballot, the authority with whom the application is filed shall review the application to determine whether it complies with the requirements as to form, content, and procedure that it must satisfy for the candidate's name to be placed on the ballot.
- (b) Except as provided by Subsection (c), the review shall be completed not later than the fifth day after the date the application is received by the authority.
- (c) If an application is accompanied by a petition, the petition is considered part of the application, and the review shall be completed as soon as practicable after the date the application is received by the authority. However, the petition is not considered part of the application for purposes of determining compliance with the requirements applicable to each document, and a deficiency in the requirements for one document may not be remedied by the contents of the other document.
- (d) A determination under this section that an application complies with the applicable requirements does not preclude a subsequent determination that the application does not comply, subject to Section 141.034.
- (e) If an application does not comply with the applicable requirements, the authority shall reject the application and immediately deliver to the candidate written notice of the reason for the rejection.
- (f) This section does not apply to a determination of a candidate's eligibility.

Appendix 7:

- § 141.063. VALIDITY OF SIGNATURE.
 - (a) A signature on a petition is valid if:
- (1) except as otherwise provided by this code, the signer, at the time of signing, is a registered voter of the territory from which the office sought is elected or has been issued a registration certificate for a registration that will become effective in that territory on or before the date of the applicable election;
- (2) the petition includes the following information with respect to each signer:
 - (A) the signer's residence address;
- (B) the signer's date of birth or the signer's voter registration number and, if the territory from which signatures must be obtained is situated in more than one county, the county of registration;
 - (C) the date of signing; and
 - (D) the signer's printed name;
- (3) the part of the petition in which the signature appears contains the affidavit required by Section 141.065;
- (4) each statement that is required by this code to appear on each page of the petition appears, at the time of signing, on the page on which the signature is entered; and
- (5) any other applicable requirements prescribed by this code for a signature's validity are complied with.
- (b) The signature is the only information that is required to appear on the petition in the signer's own handwriting.
- (c) The use of ditto marks or abbreviations does not invalidate a signature if the required information is reasonably ascertainable.
- (d) The omission of the state from the signer's residence address does not invalidate a signature unless the political subdivision from which the signature is obtained is situated in more than one state. The omission of the zip code from the address does not invalidate a signature.

Appendix 8:

§ 161.009. PARTY OFFICER SUBJECT TO MANDAMUS. The performance of a duty placed by this code on an officer of a political party is enforceable by writ of mandamus in the same manner as if the party officer were a public officer.

Appendix 9:

- § 172.021. APPLICATION REQUIRED.
- (a) To be entitled to a place on the general primary election ballot, a candidate must make an application for a place on the ballot.
- (b) An application must, in addition to complying with Section 141.031, be accompanied by the appropriate filing fee or a petition in lieu of the filing fee that satisfies the requirements prescribed by Section 141.062. A political party may not require payment of a fee as a condition to applying for a place on the ballot as a candidate for county chair or precinct chair.
- (c) An application filed by mail is considered to be filed at the time of its receipt by the appropriate authority.
- (d) The circulation of a petition to be filed under this subchapter in connection with a candidate's application for a place on the ballot does not constitute candidacy or an announcement of candidacy for purposes of the automatic resignation provisions of Article XVI, Section 65, or Article XI, Section 11, of the Texas Constitution.
- (e) A candidate for an office specified by Section 172.024(a)(8), (10), or (12), or for justice of the peace in a county with a population of more than 850,000, who chooses to pay the filing fee must also accompany the application with a petition for a place on the primary ballot as a candidate for judicial office that complies with the requirements prescribed for the petition authorized by Subsection (b), except that the minimum number of signatures that must appear on the petition

required by this subsection is 250. If the candidate chooses to file the petition authorized by Subsection (b) in lieu of the filing fee, the minimum number of signatures required for that petition is increased by 250. Signatures on a petition filed under this subsection or Subsection (b) by a candidate covered by this subsection may not be obtained on the grounds of a county courthouse or courthouse annex.

- (f) A political party's state executive committee by rule may require that an application for the office of county chair be accompanied by a nominating petition containing the signatures of at least 10 percent of the incumbent precinct chairs serving on the county executive committee.
- (g) A candidate for the office of chief justice or justice, supreme court, or presiding judge or judge, court of criminal appeals, who chooses to pay the filing fee must also accompany the application with a petition that complies with the requirements prescribed for a petition authorized by Subsection (b), except that the minimum number of signatures that must appear on the petition required by this subsection is 50 from each court of appeals district.

Appendix 10:

§ 172.027. STATEMENT ON PETITION. The following statement must appear at the top of each page of a petition to be filed under Section 172.021: "I know that the purpose of this petition is to entitle (insert candidate's name) to have his or her name placed on the ballot for the office of (insert office title, including any place number or other distinguishing number) for the (insert political party's name) primary election. I understand that by signing this petition I become ineligible to vote in a primary election or participate in a convention of another party, including a party not holding a primary election, during the voting year in which this primary election is held."

Appendix 11:

§ 172.029. LIST OF CANDIDATES.

- (a) For each general primary election, the state chair and each county chair shall prepare a list containing the name of each candidate who files an application for a place on the ballot with the chair, as the name is to appear on the ballot, and containing the candidate's address as shown on the application.
- (b) The candidates' names must be grouped on the list according to office.
- (c) Not later than the 10th day after the date of the regular filing deadline for candidates' applications, the state chair shall deliver the chair's list to the secretary of state, and each county chair shall deliver a copy of the chair's list to the county clerk, the state chair, and the secretary of state.
- (d) A candidate's name must be omitted from the list if, before delivery of the list, the candidate withdraws, dies, or is declared ineligible, or if the candidate's application is determined not to comply with the applicable requirements.
- (e) The secretary of state and each county clerk shall retain each list received until the day after general primary election day.

Appendix 12:

§ 273.061. JURISDICTION. The supreme court or a court of appeals may issue a writ of mandamus to compel the performance of any duty imposed by law in connection with the holding of an election or a political party convention, regardless of whether the person responsible for performing the duty is a public officer.

Appendix 13:

§ 273.081. INJUNCTION. A person who is being harmed or is in danger of being harmed by a violation or threatened violation of this code is entitled to appropriate injunctive relief to prevent the violation from continuing or occurring.
