#### 2) No Fees if You Don't Win Your Case.

Like most personal injury law firms, we work on a contingency fee basis. This means, if we help you win your case, we receive a percentage of the settlement amount. If we fail, you will not have to pay attorneys' fees. Either way, in most firms you might have to pay any costs associated with your case, but a personal injury attorney can explain this during your free consultation.

#### 3) Saves You Time.

At our firm, we have paralegals and medical specialists to take care of the paperwork, medical records, and maze of adjuster communication that you do not want to deal with. Then, our attorneys can take over and work with you to cut through the red tape that insurance companies put up to avoid having to pay compensation.
