NEW YORK, NEW YORK — Last week a construction worker was critically injured when a piece of concrete fell on his head in a <u>construction accident</u>, the *New York Daily News* reported. The 26-year-old man was clearing away loose concrete in a Brooklyn subway station.

According to the *New York Daily News*, the concrete slab also hit another worker in the arm. Both men work for Fox Industries.

The cause of the accident is still unknown.

"Despite all the safety regulations, it is still all too common for accidents to happen on construction sites," said David Perecman, a <u>workers' compensation lawyer in New York</u> for over 30 years.

Construction workers across New York are constantly at risk for injury. Even at a carefully supervised construction site, it is possible for a construction worker to be injured in a New York construction accident. According to the Bureau of Labor Statistics' report "Injuries, Illnesses and Fatalities in Construction" (published in 2006), 401,000 construction workers suffered nonfatal injuries and illnesses in 2004.

According to the Center for Construction Research and Training's report "Lifetime Risk of Occupational Injuries and Illnesses among Construction Workers" (2011), a construction worker has a 1 in 200 chance of dying from a work-related injury over a 45-year career. The worker has a 75% or greater likelihood of lost-time injuries over the same period of time if he or she is not killed at work.

A worker injured in a construction accident may suffer lost wages, high medical bills and, possibly, permanent disability.

"Construction work comes with considerable risk, but there are laws in place that may help protect injured employees financially," said Perecman, a <u>workers' compensation</u> lawyer in New York and founder of The Perecman Firm.
