



I. CERTIFICATE OF NEED PROGRAM

A. Emergency Application

AL2012-041-E, U.S.A Healthcare Psychiatric Services, LLC d/b/a The Sanctuary at the Woodlands, Cullman, AL: This application was filed for an Emergency Certificate of Need to relocate 20 psychiatric beds from Hartselle Medical Center, which closed January 31, 2012, to The Sanctuary at the Woodlands. This is being presented to the Certificate of Need Review Board for ratification.

Approved.

B. AL2012-033, Dialysis Clinic, Inc.-Moulton, Moulton, AL: Proposes to add two additional hemodialysis stations to the existing 10-station dialysis facility, for a total of 12 stations, one of which will be used as an isolation station.

C. AL2012-036, Chateau Vestavia Hills, LLC, Birmingham, AL: Proposes to convert eight assisted living apartments into eight specialty care assisted living apartments. The eight specialty care assisted living beds are being relocated from Faith Assisted Living and were approved under Change of Ownership 2012-016.

D. AL2012-037, Dialysis Clinic, Inc.-Pell City, Pell City, AL: Proposes to add five hemodialysis stations to the existing facility consisting of 10 hemodialysis stations, for a total of 15 stations.

AL2011-012, The Healthcare Authority for Medical West, an affiliate of the UAB System d/b/a Medical West, Hoover, AL: Proposes to establish a freestanding Emergency Department in western Hoover, Alabama. Opposition: Baptist Health System, Inc. d/b/a Princeton Baptist Medical Center filed opposition/intervention and request for a Contested Case Hearing.
