CREAMY HOMESTYLE TUNA MELTS

- 4 oz. (1/2 of 8-oz. pkg.) Philadelphia Cream Cheese, softened
- 2 cans (5 oz. each) tuna, drained, flaked
- 1/4 cup finely chopped onions
- 1/4 cup finely chopped celery
- 12 slices Whole wheat bread
- 6 KRAFT Singles
- 2 Tbsp. Butter or margarine, softened




