## JUDGMENTS

### Commonwealth

11 April 2014 - [Tamara King by her next friend Kevin King v Sydney West Local Health District \[2014\] HCATrans 78](#)

This was a special leave application to the High Court of Australia. The issue was one of factual causation - whether the failure by the respondent to administer Varicella-Zoster Immunoglobulin (VZIG) to the appellant's mother created or increased the risk that the appellant would suffer Congenital Varicella Syndrome. The primary judge, Justice Garling, found that it was not established, on probabilities, that the appellant would not have so suffered if VZIG had been administered, it was merely possible. A majority of the Court of Appeal dismissed the appellant's appeal. The High Court saw no reason to doubt the correctness of that decision. Special leave was refused with costs.

### South Australia

17 April 2014 - [Finding of Inquest into the death of Cynthia Joy Werner 8/2013 \(19889/2010\)](#)

This was a finding of Inquest into the death of Cynthia Joy Werner in the Coroner's Court of South Australia. The cause of death was colchicine toxicity. Colchicine is a naturally occurring substance derived from a plant and is predominately used for the treatment of gout.

The deceased was a 76 year old resident of a nursing home who suffered, amongst other things, acute attacks of gout for which she was co-prescribed colchicine and allopurinol. This is considered accepted professional practice and was not criticised by the Coroner.

At the time of her death, the deceased was taking colchicine at 500mg three times a day. A locum doctor was called to see the deceased and ordered the cessation of the colchicine but the patient died the next morning. An autopsy report noted her blood contained colchicine at a level of .025mg per litre which was reported to be a potentially lethal dose.

One of the experts who gave evidence was of the opinion that it was not widely appreciated within the medical profession how toxic colchicine can be. The Coroner also noted that there is some confusion in the published guidelines about the recommended dosage of colchicine.

The Coroner recommended that the Minister for Health take appropriate steps to draw to the attention of the medical community the issues with respect to the potential toxicity in the use of colchicine and the fact that there appear to be discrepancies in some of the publications related to dosage.

Death in custody - death from multi organ failure due to pancreatitis and generalised varicella zoster virus infection, due to immunodeficiency due to non-Hodgkin's lymphoma.

10 April 2014 - [Pharmacy Board of Australia v Lagos \[2014\] SAHPT 3](#)

Complainant alleges that the respondent behaved in a way that constitutes professional misconduct - respondent entered a plea of guilty in the Magistrates Court to three counts, two counts involving breaches of s 18 of the *Controlled Substances Act 1984* and one count involving a breach of reg 14 of the *Controlled Substances (Poisons) Regulations 1996* - Convictions were recorded on all three counts - A period of imprisonment of fourteen months was imposed such period of imprisonment being suspended upon the respondent entering into a bond to be of good behaviour in the sum of \$500 for a period of two years - In addition a fine of \$1,500 was imposed - At the hearing of this matter the respondent admitted that the three grounds alleged in the Complaint constituted professional misconduct - Respondent currently on the register of pharmacists but conditions are imposed on his registration - Complainant submits that due to the respondent's admissions the appropriate public protection and the aims of the discipline can be achieved by a reprimand - That the respondent be retrospectively suspended for the twelve month period he was off work - That in the circumstances that prevail a further period of suspension will not be imposed - That the current conditions continue to apply to the respondent's registration for twelve months and then be reviewed by the complainant - That the respondent make a contribution towards the complainant's costs of and incidental to the within proceedings - Held: The conduct set out in the Complaint constitutes

professional misconduct - Ordinarily a period of suspension would be imposed but given the respondent's time out of practice, the supporting psychiatric evidence, the admissions of professional misconduct and the efforts towards rehabilitation a further period of suspension will not be imposed - The current conditions continue to apply to the respondent's registration for a further twelve months and are then to be reviewed by the complainant - The respondent to make a contribution towards the complainant's costs of and incidental to the within proceedings fixed at 30% of the costs to either be agreed or in default of agreement to be taxed - The payment of costs to be deferred for a period of twelve calendar months from the date of this order - S 193 *Health Practitioner Regulation National Law (South Australia) Act 2010*.

## Tasmania

24 March 2014 - [Tasmanian Board of the Medical Board of Australia v Dr David Edis \(Ref No 4/2013\) \[2014\] TASHPT 1](#)

This was an application by the Medical Board to the Tasmanian Health Practitioners Tribunal for a determination that the conduct of a surgeon amounted to professional misconduct.

The surgeon was to perform surgery at level C3/4 of the patient's spine in an endeavour to alleviate the neck pain experienced by the patient. A post-operative x-ray revealed a pedicle screw fixation of the C2/3 level and the laminectomy, as well as the removal of the C3 spinus process. The surgeon failed to disclose to the patient or to others treating the patient, that he had undertaken surgery at the wrong level of the cervical spine.

The Tribunal found that the deceptive post-operative dealings amounted to professional misconduct because it fell below the basic tenet required of the medical profession to be forthright, open and honest in the performance of professional duties. In determining the sanctions to be imposed, the Tribunal considered that the surgeon had excessive work demands, did not have a healthy lifestyle balance, had a lack of peer professional network to support him and was under considerable stress to support his wife and young family.

The Tribunal reprimanded the surgeon, suspending his registration for one month. The Tribunal also imposed conditions on the surgeon's registration for two years, including mandatory reporting of any adverse events, random audits of patient records, peer review audit of management complications every 6 months, conferral with a mentor and completion of a Process Communication Module within 12 months.

### United Kingdom

16 April 2014 - [Aspinall v Secretary of State for Health \[2014\] EWHC 1217 \(QB\)](#) On 8 April 1982 at 21:55 hours the Claimant was born at Queen's Park Hospital, Blackburn. He was delivered at 32 weeks gestation by Caesarean section, weighing just 1400 grams. He was born in poor condition, there being no signs of life other than a heart rate below 100 beats per minute. He was successfully resuscitated, taking his first breath at three minutes and achieving regular respiration by seven minutes. By ten minutes he was ascribed an APGAR score of 9/10. However, on transfer to the Special Care Baby Unit (SCBU) after 20 minutes he was suffering from hypothermia with a temperature of 33.5°C. He was reintubated with a nasal tube and placed on a ventilator. Over the following hours he was given intensive care, but suffered from both respiratory and metabolic acidosis and from hypercarbia. It is common ground that the Claimant

developed hyaline membrane disease, a stiffening of the lungs which was a risk for any premature baby in 1982. It is also common ground that at some point he suffered a bleed in his germinal matrix, leading to intraventricular haemorrhage, hydrocephalus and the development of venous cerebral infarction.
