The Center for Business and Economic Research (CBER) at UNLV hosted the 2009 Economic Outlook Conference at the Las Vegas World Market Center on December 11<sup>th</sup>. Keith Schwer, director of the CBER and Constant Tra, CBER associate director, presented research that forecasts the economic conditions of Southern Nevada and the United States. This is the 17th year the economic outlook conference has been presented by the CBER. # Happy New Year! – Is It Time for a Business Check Up?

Nevada is proud of its independent business spirit and the role of the independent business owner in that environment is significant. As business opportunities continue to present themselves at a flurried pace in our robust business environment, it is easy for a business owner to overlook the organizational, record-keeping, and other business details that should, and oftentimes must, be observed in order to protect that business and ensure that it has the opportunity to flourish, rather than flounder.

In our practice, we frequently encounter business owners who have overlooked the payment of their annual filing fees to the Nevada Secretary of State, resulting in their corporation or LLC falling into a "default" status. The primary reason for forming a corporation, LLC or other like entity is to limit, to the greatest extent possible, the personal liability of the business' principals for the errors or omissions of the entity. Failure to maintain the entity's good standing with the Secretary of State is a common mistake that jeopardizes the protection of the individual business owners that entity formation is designed to provide. Likewise, many business owners overlook routine record keeping in the nature of corporate minutes and resolutions, or keeping stock registers and other records of ownership up to date. While the record keeping can be brought current annually, or periodically throughout the year, a consistent failure to maintain and update such records can also endanger the protections afforded by forming the entity in the first place. Your business lawyer is the appropriate person to review the status of your corporate filings and record keeping to ensure that your business is positioned to take advantage of the protections that Nevada law allows.

Stepping back a bit, perhaps your business exists only as a sole proprietorship. While that business form is recognized, it exposes the business owner to total personal liability for the actions of the business. A widewpracean/post/document/iewaraees/fidaeaageeaabeeaafeetheet17b-85ceaaage to reorganize that sole proprietorship into a corporation, LLC or other form that will offer greater protection. Similarly, a business owned and operated by more than one owner, yet not officially organized into a corporation, LLC or other entity, may nonetheless be deemed a partnership under Nevada law. Hence, with no intent to do so, those owners may have taken on fiduciary duties to one another in the nature of sharing profits and losses in an equal manner and co-owning business property. This situation exposes the owners not only to liability to third parties for the actions of the business, but also, unwittingly, to liability to one another to observe partnership formalities imposed by Nevada law.

There are a host of benefits and detriments to the formation of one type of business entity or another depending on the nature or the business and the owners' goals. That analysis is beyond the scope of this article and would also warrant the input of your tax professional as to the myriad of taxation issues that can be addressed through the formation of one type of entity or another. It suffices to say, however, that your business could benefit from adding a visit with your business lawyer to your list of New Year's resolutions.

According to the Nevada Secretary of State Quarterly Business Report, new entity filings have decreased 13.98% over the first 5 months of the 2009 fiscal year as compared to the same period in the 2008 fiscal period.<u>http://secretaryofstate.biz/information/news/</u> <u>quarterlyreports/docs/2008Quarter3web.pdf</u>. Despite the current economic condition, Clark County has still continued to see a constant stream of new residents. According to the Nevada Department of Motor

Vehicles, "over 4,400 new movers came to Clark County in November, bringing the 2008 new mover count to more than 60,000." In contrast, according to the Las Vegas Convention & Visitors Authority, "just over 3 million visitors came to Las Vegas in October, a 10.2% decrease over last year. Despite the decline in visitors, occupancy rates still remain 20-25% higher than in most markets." According to the Clark County Department of Aviation, "nearly 3.6 million passengers traveled through McCarran International Airport in October, a 12.8% decrease from 2007." According to the Nevada Department of Employment, "the unemployment rate in Nevada reached 8% in November, while the rate in Las Vegas hit a record high of 7.9%." However, "total employment in Las Vegas is up 1.7% from last year to 935,000, and the labor force has grown 4.7% to 1.015 million." Economists at the UNLV CBER "are optimistic that Southern Nevada will see a turnaround in 2009, with only personal income forecasted to have negative growth. All major factors are expected to show positive growth in 2010."

# FYI: NEW YEARS BUSINESS LAW TIPS

\* Remember to pay your annual filing fees to the Nevada Secretary of State.

\* Tax time is just around the corner. Consult with your accountant or CPA to prepare for the impending deadline.

\* Routine record keeping in the nature of corporate minutes and resolutions, or keeping stock registers and other records of ownership should be kept up to date. Your business lawyer is the appropriate person to review the status of your corporate filings and record keeping ensuring that your business is positioned annually to take advantage of the protections that Nevada law allows.

\* Now is a good time to decide whether you should investigate reorganizing your sole proprietorship into a corporation, LLC or other form that will offer greater protection. Your business lawyer is the appropriate person to discuss what business entity is appropriate for your particular needs.
