Supreme Court Rules On "Honest Services" Fraud

On June 24, 2010, the U.S. Supreme Court issued a ruling in <u>Skilling v. U.S.</u> that limits the application of the federal "honest services" fraud statute only to cases involving bribery and kickback schemes. Since the federal statute frequently had been used by prosecutors in cases involving conflicts of interest or other conduct not covered by other criminal statutes, the Supreme Court's ruling will invariably impact federal prosecutions of government contractors, as well as federal, state, and local public contracting officials.

Under the federal "honest services" fraud statute, an unlawful "scheme or artifice to defraud" includes a scheme "to deprive another of the intangible right of honest services." 18 U.S.C. § 1346. In *Skilling*, Enron CEO Jeffrey Skilling appealed his conviction of conspiring to commit "honest services" fraud, arguing, in part, that the "honest services" fraud statute should be void because it is unconstitutionally vague. Declining to invalidate the statute, the Supreme Court, chose instead to limit its scope.

Concluding that the statute codified federal common law that was developed in cases that mostly "involved fraudulent schemes to deprive another of honest services through bribes or kickbacks supplied by a third party who had not been deceived" the Supreme Court ruled that the "honest services" fraud statute should be limited to conduct involving bribes and kickbacks. While recognizing an overlap with the principal federal bribery statute under 18 U.S.C. § 201, the Supreme Court determined that the "honest services" fraud statute's "application to state and local corruption and to private-sector fraud reaches misconduct that might otherwise go unpunished."

The Supreme Court rejected the U.S. Government's argument stating that prohibited conduct under the statute should be construed to include "undisclosed self-dealing by a public official or private employee." Perhaps anticipating a Congressional response, the Supreme Court stated "[i]f Congress desires to go further, it must speak more clearly than it has."

In a dissenting opinion, Justice Scalia concluded that even under the majority's limitation, it remained unclear whether the "honest services" fraud statute applies only to public officials, to private individuals who contract with the public, or to corporate officers.

On the same day it reversed the conviction in *Skilling*, the Supreme Court also reversed and remanded two other "honest-service" fraud cases, in light of its ruling in *Skilling*: <u>Black v.</u> <u>U.S.</u> and <u>Weyhrauch v. U.S.</u>

BITS ON BIDS: Recent GAO Rulings on Bid Protests

In Re DGR Associates, Inc.

In a case involving a decision by an agency to set aside a procurement under the 8(a) program rather than under the HubZone program, the GAO ruled in favor of a HUBZone bid protester. The GAO decided that the HUBZone statute requires a contracting agency to issue a solicitation as a HUBZone set-aside if the conditions for a HUBZone set-aside exist: specifically, if the agency has a reasonable expectation of receiving offers from two or more qualified contractors and the award can be made at a fair market price. The GAO distinguished the 8(a) setaside statute that gives agencies discretion to solicit bids as setasides. The GAO also refused to give deference to a Department of Justice memorandum instructing Executive Branch employees to place different categories of small businesses on equal footing.

In re AlalamiahTechnology Group

The GAO denied a protest by a bidder whose proposal was deemed late because it was received by email after the closing time for submission of proposals. In that case, the bidder submitted its proposal by e-mail in three separate volumes, the last of which was sent at 10:00 am - the closing time for bids. The contracting official, however, received the *e*-mails containing the proposal volumes at 10:03 am, 10:08 am, and 10:11 am, respectively. The GAO concluded that RFP requirements on bidders to "submit" offers by a certain time required offers to be received by that time.
