Strong led the Pillsbury team that worked with regulators and the university to resolve compliance issues, settle the civil enforcement action and help get the labs back online.

In 1989, Strong received a B.S. in civil engineering from Texas A&M before securing his J.D. from South Texas College of Law in1994. Licensed to practice in both Texas and Louisiana, Strong has worked with government entities, public universities and private clients.

As GC, Strong will be responsible for all legal matters affecting the nine-member Texas A&M system, which services 109,000 students annually, as well as seven state agencies and the Texas A&M Health Science Center. He will also provide legal counsel to the Board of Regents, chancellor and CEOs.
