

# **Mobile Technologies Advancing Litigation Support Services**

As communication technology continues to grow at an exponential rate, lawyers, court reporters and other members of the legal field are using their mobile devices more than ever for <u>litigation support</u> purposes. According to surveys conducted by the American Bar Association and independent agencies, over 80% of attorneys used a smartphone in the past year for business purposes, and almost 25% have downloaded and used at least one legal industry mobile application to help them perform their duties with much greater efficiency. ## Online Accessibility

The most obvious benefit that mobile technology affords an attorney is the ability to access and share files online. This saves money and enables the attorney to get a lot more accomplished in significantly less time.

## **Trial Support Applications**

Mobile application technology doesn't stop at just assisting in trial preparation, they can also be used to help attorneys make more compelling presentations during the trial. By utilizing specific legal applications, a lawyer can index and organize documents, advance exhibit preparation and more. Since all of the materials are converted into online files, documents are organized into easily searchable databases that can be used for review or presentation production quickly and efficiently. Attorneys can also download law libraries and legal dictionaries like Black's Law Dictionary and more for reference during depositions and trials.

#### Logistics and Office Functionality

While some of the more technical and legal-specific applications get most of the attention, the ability to provide the attorney with full office functionality is often the most-used area of mobile litigation support applications.
