'tis the Season...to start

If you are like most business owners, you've spent the last quarter of the year pushing off new projects or putting off the thought of changing anything until "after the 1st of the Year". Guess what? You're running out of time!

If you haven't already investigated and found ways to improve how you get things done in 2011, likelihood is, you'll continue using the same inefficient or even antiquated business processes for another full year.

Here's 3 simple things I share with my clients in order to help them improve their workflow:

1. Write stuff down in the same spot. Notebook or my preferred: a calendar with large notes section for each day. I don't like an electronic device for this task as your brain thinks differently when holding a pen and writing. Keep this notebook/calendar with you AT ALL TIMES. Even if you are just running out to do something. Waiting in line, while in traffic or at the doctor's office is a great time to go through past entries and/or undate your calendar

- 2. Use your calendar fully. Don't just mark deadlines and appointments. Schedule the time you need to complete incoming items and projects you identify from all that stuff you're now writing down. I also like to block out a few mornings each week for writing projects and a few afternoons for phone/filing/admin type work.
- 3. Compile your contacts. You know you have 100's (if not 1000's) of business cards lying around. Gather them all into one spot (shoebox, old pocketbook, large envelope) and get them added to your electronic rolodex/contact management software. This is one of those projects that is best broken down into smaller bits. Scan or type 10 a day, until they are all entered. Eventually, you will have all your contacts in one spot and organized – ready to be asked if they can be added to your newsletter list or other keep in touch marketing materials.

Implement these 3 small changes and reap the benefits of an improved workflow in 2011.

Scrivener

Outline. Edit. Storyboard. Write.

Many people remember the word 'scrivener' from Herman Melville's short story, Bartleby the Scrivener. Melville's character is best remembered as a drone office worker who "preferred not to" do any work. Bartleby's signature line echoed in my brain when I heard several respected writers raving about a great writing program for the Mac called "Scrivener." Since these were respected writers who recommended the program as a revolutionary way of writing, I wasn't going to dismiss it. But, as I contemplated the prospect of actually learning to use it, I thought "I'd

prefer not to."

Out of guilt, and perhaps some curiosity, I did make a few lame efforts to probe the benefits of Scrivener. For the most part, I failed to grasp its utility for a lawyer. Recently, however, I decided to make a stronger effort and now I can say that Scrivener is an indispensable tool for all of my writing. So, here I go with the pitch: I know you'd prefer not to learn to use a new writing program, but this one is worth it even Windows users (I'll explain why at the end.

In a nutshell, Scrivener has created a writing environment that makes it easy for people who create

complex documents to focus on assembling those documents with minimal attention to needless aspects of document creation such as formatting. Scrivener is particularly well suited for those dependent on research.

Here's how I used it recently to create an Opposition to a Motion to Dismiss. If you look at the red box labeled #1 in the screenshot, you'll see a "Research" folder with sub-items. This is where I can drag URL's, PDFs, Word documents etc.


For this project, I dragged and dropped a PDF copy of the memo in support of the motion, along with PDFs of key cases that relate to the law I would be dealing with.

In the green box (labeled #2), I created a "Draft" folder where I have started to assemble short modules of text that relate to one section, or part of a section, of my working document. The beauty of Scrivener is that it assumes that I will be working on lots of different sections, and it allows me to do that without having to worry about the exact order of those sections. I can always drag them into different positions later.

The area inside the blue box (labeled #3) is where I write each section of text. Before starting, I define which section I'm working on by clicking on one of the modules listed in area #2.

Since I am preparing an opposition to a motion, I created sections for each argument made in the papers drafted by my adversary. I may not need one section for each argument, but for now this it helps me see what the structure of my document will be. At any time I can merge sections, break up long sections, create new sections and move them up and down, rearranging their order.

The area colored in orange labeled #4 is where I can view my research documents or the opponent's memo. Once I have



completed all the sections and filled them with text. I am ready to finalize the document by selecting the "compile" option. I then decide what I want to include and what format the final file should be. I can choose to output only certain sections (which allows me to keep a section I worked on but

have decided not to include in the memo), and I can opt for a different font style or change my formatting in any way I want.

The last step involves cleaning up the document in a program like Word or Wordperfect, which is quick and painless because there is nothing left to do except the formatting. Scrivener creates the output as an RTF file, or an RTF-D should you wish to embed/include image files with the text.

Scrivener is a powerful tool, and it's perfect for legal writing.

I know you'd prefer not to learn a new writing program, but trust me this one is worth investigating. And if you have a Windows computer I have good news: there is beta version available (http://legaltypist.com/scrivenerforwindows) that has all the features I mentioned. Check it out if you want to make it easier to create those complex legal documents you are always agonizing over.

- 1 ¼ pound unsalted, assorted nuts (pecans, cashews, peeled peanuts, unpeeled almonds, etc.)
- 2T coarsely chopped rosemary
- ½ teaspoon cayenne
- 2 teaspoons dark brown sugar
- 2 teaspoons kosher salt
- 1 tablespoon butter, melted
- 1. Preheat the oven to 350° F
- Toss the nuts in a large bowl to combine and spread them out on a cookie sheet. Toast in the oven until they become light golden brown, about 10 minutes.
- 3. In a large bowl, combine the rosemary, cayenne, brown sugar, salt and melted butter.
- 4. Thoroughly toss the warm toasted nuts with the spiced butter.

Pants and Boots

Creating a Multi-Location Firm on a Shoe String Budget by Craig Bayer

I was recently approached by three attorneys that wanted to merge their practices into one firm. The unique challenge was they all lived in different cities. They needed to be able to view and collaborate on documents, record time and create pre-bills, and be able to email and view each other's calendars. They also needed a billing and accounting program to keep track of all of their time and expenses.

Five years ago they would have had to purchase two servers, one for exchange and one for terminal services. One office would be designated as the main office and the other two attorneys would remote into the terminal server. This would have been around a \$10,000 project. Now, with technology advances, this can be done for a fraction of the price. There are three solutions I used to achieve the firm's needs:

Microsoft Exchange Online for their email and calendaring. This cost's \$25 a month (\$300 a Year) for 5 email addresses.

DropBox for as the file server. DropBox is free for the first 2gb, \$10 a month for 50GB and \$20 a month for 100GB. Since they are just starting off and don't have that many documents they would be paying no money for DropBox.

PCLaw for Time, Billing, and Accounting software. Besides being an amazing legal accounting package, it has a satellite version which allows users in remote locations to record time entries and simply email a file to the main office that is takes one mouse click to import. Here are the advantages of the System:

- All the firm's documents and files instantly synced to each machine: It takes about 3 seconds (depending on file size) for a document saved in one person's DropBox to appear on another user's machine.
- 30 Days* of Previous Versions of Documents:
 DropBox stores 30 days of previous versions of documents. Therefore if you accidentally delete or wipe out changes to your documents, DropBox will allow you to easily restore. *Other DropBox versions allow unlimited versioning.
- Online Backup Included: All the firm's documents
 are stored on each user's machine and on the
 DropBox Server. PCLaw is setup to automatically
 backup at night into a folder in DropBox, so that is
 automatically backed up toDropBox's server as
 well. Microsoft Hosted Exchange has a stored copy
 of everyone's Outlook on its servers.
- Online Access to Documents and Email: Microsoft Exchange Online allows you to view your Outlook in a browser and DropBox allows you to log into their site and download or upload any document.
- Smart Phone Access to all your Documents:
 DropBox has a free App for the Blackberry, Android, iPhone, and iPad. These apps allow you to view and email documents. Depending on your device, you have the ability to edit them as well.

- Work Offline without any extra steps: If you are on an airplane, and open your laptop DropBox, Outlook and PCLaw will allow you to work offline. When you get back to the office, you don't have to do anything besides turning on your machine to reconnect.
- The Firm always has all their Data: Microsoft and DropBox do store copies of your data on its servers but you have all the same data on your machines. If you canceled your Microsoft Online and DropBox Accounts, the Data would not be syncing to the cloud or to other machines but it would still be on your machines.
- Minimal Maintenance: The Firm does not have to worry about their raid array crashing on their server and not being able to get to their documents or email. DropBox and Hosted Exchange are cloud based solutions but they use a synchronize method instead of having all your data just stored in the cloud. Therefore, if DropBox went down, you would not be getting new documents from other users, but you would still have all the documents on your machine.
- No Accidental Deletions: In a traditional Server environment, if you accidentally delete a document from a Network Share it is gone for good. DropBox will keep a copy of that document for 30 days.
- Cheap: An Exchange Server and a Terminal Server would cost two to three thousand dollars each and probably \$4000 in consulting costs to set them up. That is not including additional costs like firewalls. We have replaced the servers with DropBox and Outlook which costs \$25 a month for 5 users.

There is No Such Thing as a 'National' Criminal Background Check for \$29.95

A comprehensive background investigation is a must do for principals involved with various business transactions, private investments, bringing in new partners, examining suppliers and reviewing key hires for any company. In spite of what many background screening companies across the country claim and try to sell you, there is no such thing as a "National Criminal Record Database Check for \$29.95."

Even when a firm does enjoy privileged access when undertaking criminal investigations on behalf of corporate clients and working with law enforcement, the data compiled by the National Crime Information Computer (NCIC), maintained by the FBI, the Law Enforcement Information Network (LEIN), maintained by each individual state, and other government information assembled by law enforcement on criminal matters IS NOT AVAILABLE for sale to private industry, and such sale or unauthorized access would violate both federal and state law.

Best [research] methods for decision makers in the private sector to verify identity and achieve optimum results for criminal and civil record research in the U. S. include the following:

- Verify the subject's social security number. This will show that the SSN was actually issued to this person as well as when and where it was issued.
- Hand-search county court records in each jurisdiction where the subject has resided based on his or her address history. The statistical example: 85% of all arrests and convictions occur in the county of residence. However, take care when selecting your research supplier they should be able to provide thorough research coverage extending to all 3,227 (or so, at last count) state counties, independent cities and township or village corporations across the United States.
- Complete a federal criminal records search. A
 federal conviction or other information which
 indicates the subject may be or has been involved
 with federal authorities will not be revealed in a
 state county records check.

- Narrow an online search of the thousands of news feeds for an arrest hit, if found, verify disposition of charges at the court of proper jurisdiction.
- Become familiar with the Fair Credit Reporting Act-"FCRA", available online prior to hiring employees. Any background research for employment purposes, (including obtaining a credit report), requires a separate stand-alone written release from the candidate. Most states have adopted the FCRA model in their respective legislation and several states also have further compliance mandates you need to follow. For due diligence review matters regarding private equity closings and other consumer initiated commercial transactions, the rules are a little different.

My experience with government services, particularly consulting on investigations and reviews of candidates applying for sensitive positions requiring U.S. Government security clearances, a clear disqualifier for most is when information is not voluntarily disclosed and discussed up front. People make mistakes; this does not mean they're bad people. And, events do occur in life requiring each of us to face many challenges at times, such as a medical bankruptcy or other factors resulting in unforeseen financial distress.

Criteria for refusal of a candidate should not be automatic upon the disclosure/discovery of negative or potentially adverse information. A frank discussion with the candidate or potential business partner to review background information is certainly appropriate. If you choose to proceed after these discussions, remember - trust is important, but verify.


"Sing we joyous, all together"
