- A customer fails to pay after substantial time and many promises
- You receive a notice/letter from a government or regulatory agency
- A former employee sets up a competing business and signs one of your accounts or hires some of your employees
- Your standard form contracts are outdated or challenged by others as unenforceable
- You have a problem or dispute with a third party, be it your landlord, a customer, supplier or someone else.
- You learn of an employee problem, which could be a complaint about pay and overtime, harassment, violation of company policies or other matters.
- A workplace injury or safety issue is brought to your attention
- Your intellectual property (copyright/trademark/patent/trade secret) has been infringed upon or otherwise compromised

What should you do when these things occur? Seek the advice of a trusted and experienced attorney. And do so as soon as possible.

As your relationship with an attorney grows, you will be more comfortable allowing them to examine your business structure, operations and relationships in advance, and offer proactive suggestions that may avoid problems before they arise, or help you position your business to deal with such issues in a more cost-effective and successful manner.
