PETITION FOR DIVORCE UNDER CIVIL CODE ARTICLE 969

The petition of Nicole Lynn Hanner, a person of the full age of majority and domiciled in the Parish of West Baton Rouge, State of Louisiana, respectfully represents:

1.

Made defendant herein is Joshua Caleb Hanner, a person of the full age of majority and domiciled in the Parish of West Baton Rouge, State of Louisiana.

On the 19th day of April, 2006 in West Baton Rouge Parish, Louisiana, the Petitioner/Plaintiff and Respondent/Defendant married and their matrimonial domicile was in West Baton Rouge Parish. An official copy of the marriage license is attached to this PETITION FOR DIVORCE.

This Court is that of proper jurisdiction to hear this cause. The Respondent/Defendant has agreed to file an Affidavit of Consent in this cause. Neither the Petitioner/Plaintiff or Respondent/Defendant has been involved in any litigation or other proceeding involving the other party in this or any other jurisdiction with respect to their marriage or any other matter.

Petitioner/Plaintiff now desires to obtain a judgment of divorce a vinculo matrimonii with Respondent/Defendant based upon irreconcilable differences. The parties did not enter into a covenant marriage pursuant to R.S. 9:272 et seq.

Of the marriage, two children were born, namely Trinity Jane Hanner, age 3 years and 6 months and Christian Anthony Hanner, age 1 year and 11 months. The minor children currently resides with the Petitioner/Plaintiff.

The Petitioner/Plaintiff avers that it is in the childrens best interest that Petitioner/Plaintiff be awarded full legal and physical custody, with reasonable visitation rights to Respondent/Defendant.

Respondent/Defendant was previously ordered to pay child support in the amount of Four Hundred (\$400.00) Dollars per month through Support Enforcement proceedings and petitioner requests that this amount be confirmed in these proceedings.

Petitioner/Plaintiff and Respondent/Defendant have not entered into a Marital Settlement Agreement.

Petitioner is a citizen of this State and because of her poverty and want of means, she is unable to pay costs, either in advance, or as they accrue, or to give bond therefore, and requests that she be allowed to file and prosecute this action in forma pauperis as per L.S.A. C.C.P. Article 5181-5188.

NOW, THEREFORE, Petitioner/Plaintiff requests that the court order a FINAL JUDGMENT OF DIVORCE and such further relief as Petitioner/Plaintiff may have requested herein.
