

Pace Football Players Sue for False Arrest, New York Civil Rights Violation Lawyer Investigates

As soon as the charges against them were dropped, players announce they plan to sue the New York police who arrested them after an officer killed their teammate.

NEW YORK, NEW YORK – Criminal charges against four Pace University football players who were with teammate Danroy Henry Jr. when he was killed by police were dropped. Now they are suing for [false arrest](#), malicious prosecution, [police brutality](#) and [civil rights violation in New York](#).

“When someone is falsely arrested it is important to clear the record in order to avoid embarrassing or damaging effects of having a public criminal record,” said [New York civil rights violation lawyer](#) David Perecman.

Pleasantville Police Officer Aaron Hess and Mount Pleasant Police Officer Ronald Beckley fired on Henry's car as he drove from a fire zone outside a restaurant-bar in Thornwood, New York. Henry's car had hit two police officers who had responded to a rowdy scene. When Henry did not stop the car, the police officers fired at him

Twenty-year old Henry died at the scene. One of the police officers who was hit by Henry's car was seriously injured.

The four Pace players, Yves Delpeche, Daniel Parker, Joseph Garcia and Joseph Romanick, all of New York, were accused of disrupting police efforts to control the crowd after the shooting and interfering with efforts to aid Henry. Delpeche was shot with a stun gun.

A Westchester, New York grand jury declined to bring [police brutality](#) charges, or any other civil rights violation charges, against the two police officers who shot and killed Henry.

In a move [New York civil rights violation lawyer](#) Perecman agrees with, the U.S. Department of Justice said it would review the case for possible civil rights violation crimes. Henry was black, and the police officers accused of police brutality and [false arrest in New York were white](#).
